Peace Officer now e-ticketing

Flagstaff County has adopted an electronic ticketing system for traffic violations.

E-ticketing, which officially began in the County at the start of 2023, will speed up the enforcement process, reducing the amount of time spent roadside and thereby enhancing safety for both officers and motorists.

The new technology allows officers to scan a driver's licence and instantly pull up the driver's information. It also ensures that the information on each e-ticket that is issued is accurate and legible.

Although the system is digitized, motorists can expect to receive a paper copy of the e-ticket.

"There will be some challenges in the beginning learning a whole new system, but there will be many benefits in moving towards an electronic format," says Flagstaff County Peace Officer Skyler Zelinski.

E-ticketing is already used by many other law enforcement agencies across the province, and eventually will be used by all agencies, streamlining the administration and court process.

2022 Programs and Services



Within the 2022 Gravel Program, Public Works crews graveled 383 miles of roadway. This includes the application of gravel for roads on the five-year re-gravel cycle, arterial routes, and 2021 and 2022 road recovery projects.



Within the Dust Suppressant Program, a total of 28 strategic locations and intersections were sprayed with MG 30 dust suppressant.



Public Works crews completed a planned 26.5 miles under the 2022 Road Recovery Program. The Road Recovery Program is designed to rehabilitate road structures, restore drainage, and dispose of any rocks and regrowth of trees and shrubs within the right-of-way. Shoulder pulling, a major facet of the Road Recovery Program, is a process that extends the life of the road and reduces maintenance costs. This process includes drainage improvements, culvert replacement, reshaping back slopes/ grade slopes, re-compacting the subgrade utilizing a soil stabilization product and re-establishing the road surface crown, and is applied to roads in excess of 10 metres wide.

Winter Road Maintenance

Roadways are cleared of snow as necessary. During normal winter conditions, collector and local roads should be cleared of snow within four days and arterial roads should be cleared of snow within one to two days, unless there is heavy snow and persistent winds.

Collector and local roads are cleared utilizing a fleet of nine graders, each responsible for an average of 120 to 160 miles. Two graders are allocated for snow and ice removal on arterial roads. One plow truck is designated to remove snow and apply sand/salt to oil surface and paved roads. Upon request, a field access road may be plowed, one time only, to permit access to grain bins and/ or to re-locate livestock.

Please keep in mind that our crews will be out working on our roadways and to use extreme caution while travelling on these roads when they are being maintained in any way. Snow removal from municipal roadways is not permitted without first obtaining permission from Public Works.

To keep our roadways safe this winter, please refrain from depositing snow and ice from residential laneways onto roadways, right-of-ways and municipal ditches. Depositing snow and ice onto property other than your own can have the following adverse results:

- Slowing down Flagstaff County's snow removal process;
- Damage to roads and road maintenance equipment;
- Blocking or damaging culverts, which can lead to flooding issues in the spring;
- Damage to utility lines and roadside vegetation;
- Increasing safety hazards for motorists;
- Damage to snow plow blades.

Culvert Repair/Replacement

This fall, crews completed four large diameter culvert replacements/repairs:

- BF# 77282 SW 06-44-16 W4 (Twp Rd 440) south of Daysland;
- BF# 74378 SW 23-42-11 W4 (Twp Rd 423) south of Lougheed;
- BF# 81558 SE 30-40-13
 W4 (Twp Rd 404) north of Alliance;
- BF # 78046 –
 SE 22-41-13
 W4 (Rge Rd 132) north of Alliance.

Residential/Field Access Approaches

The construction of an approach within a road right-of-way requires the prior approval of Flagstaff County. Approval will only be granted where the requested location is considered practical and safe.

All approaches shall be constructed in accordance with the standards provided in Schedule A - Approach Design and Construction Standards. Each quarter section of land is to be provided one approach by the County if there is no existing approach; construction will be scheduled and performed with County equipment upon availability. Where a subdivision is created, approaches, including culverts and crossings to the proposed parcel and to the residual of the land, shall be provided at the owner's and/or developer's expense and to the specifications and satisfaction of Flagstaff County. At the owner's request, the approach may be constructed by the County provided that County equipment is available (cost billed to owner at County cost). Under

this provision the landowner must provide reasonable and sufficient notice of scheduling.

Landowners may request additional approaches or an approach to be upgraded or extended. The County will supply and deliver, at a cost to the landowner, a culvert or culvert extension if required. Material (i.e. clay) required to construct the approach subgrade is to be sourced (supplied and located in close proximity to the worksite) by the landowner. The County will schedule the resources to complete the work upon availability.

Gravel is required on all approaches; the gravel may be supplied by the County at a cost to the owner. Where the County is undertaking a road construction or road recovery project, affected approaches will be graveled.

All requests for access off a provincial highway fall under provincial jurisdiction.

NOTICE OF PUBLIC HEARING

LAND USE BYLAW

Pursuant to the Municipal Government Act, R.S.A. 200, Sections 230, 606 and 692 of Flagstaff County hereby gives notice of its intention to adopt:

Bylaw 01/23 Flagstaff County Land Use Bylaw

The purpose of this bylaw is to repeal and replace existing Flagstaff County 09/18 and approve a new Land Use Bylaw.

MANY CHANGES have been made in the proposed Land Use Bylaw which may have an effect on some individuals. Some of these changes include:

- Expanded and updated list of definitions
- Insertion of a new section related to subdivision to provide a transparent overview of the existing subdivision process and conform with amendments to the Municipal Government Act
- Updates to the Enforcement section to align the LUB with existing County bylaws and to reflect advice from the County's solicitors
- Revisions to the lists of Permitted and Discretionary Uses within the existing Land Use Districts to reclassify uses with the potential to create offsite impacts or land use conflicts from the Permitted Use category to the Discretionary Use category
- New Development Permit requirement for cannabis retail sales establishments
- Changes to the Land Use Districts Maps

THEREFORE, TAKE NOTICE THAT pursuant to Sections 606 and 692 of the *Municipal Government Act* a public hearing to consider the proposed Bylaw will be held:

It would be beneficial for individuals to provide advance notice to Flagstaff County at 780.384-4100 of their intention to make a presentation at the hearing.
