A BYLAW OF FLAGSTAFF COUNTY OF THE PROVINCE OF ALBERTA TO AMEND THE FLAGSTAFF COUNTY/TOWN OF DAYSLAND/VILLAGE OF FORESTBURG INTERMUNICIPAL COLLABORATION FRAMEWORK.

WHEREAS the Council of Flagstaff County passed the Flagstaff County/Town of Daysland/Village of Forestburg Intermunicipal Collaboration Framework Bylaw 04/20, to establish an agreement between municipalities that share a common boundary on how services are funded and delivered;

AND WHEREAS

- 1. Pursuant to the Municipal Government Act, RSA 2000, Chapter M-26, as amended, Flagstaff County and Town of Daysland and Village of Forestburg entered into an Intermunicipal Collaboration Framework (hereinafter referred to as "ICF") in March 2020.
- 2. The ICF requires a review at least once every five years.
- 3. The Government of Alberta has indicated its intent to introduce amendments to the Municipal Government Act in the Spring of 2025 that will pertain to ICF's.
- 4. The Government of Alberta has recommended that municipalities with ICF's that require a review prior to 2027 attempt to work with each other to delay the review process until the Spring of 2027.
- 5. Neither Flagstaff County nor Town of Daysland nor Village of Forestburg have indicated a need to review the ICF prior to Spring of 2027.

AND WHEREAS pursuant to section 191 of the *Municipal Government* Act a council is authorized to amend a bylaw;

NOW THEREFORE the Council of Flagstaff County hereby enacts as follows:

1. This Bylaw shall amend the Flagstaff County/Town of Daysland/Village of Forestburg Intermunicipal Collaboration Framework Bylaw, as follows:

Part 1.4 Term and Review is amended as follows:

- 3. It is agreed by the participating municipalities that the Intermunicipal Collaboration Committee shall undertake a formal review of the Intermunicipal Collaboration Framework no later than 2027, and thereafter at least once every 5 years.
- 2. Flagstaff County / Town of Daysland / Village of Forestburg Intermunicipal Collaboration Framework Bylaw, in all other respects, remains the same.
- 3. This Bylaw becomes effective on the date it is signed and passed.
